High-Tech Security Features

Hoosic Valley CSD will implement a districtwide emergency notification system. The project deploys Singlewire InformaCast Fusion for mass notification with IP speakers, digital displays, outdoor horns and strobes covering all classrooms, hallways, cafeterias, gyms and outdoor areas. A fiveyear subscription provides cloudhosted alerting to phones, desktops, digital signage and mobile devices. The system integrates with panic buttons and automatically triggers lockdown, evacuation or weather alerts across multiple modalities, supporting Alyssa's Law, Kari's Law and the Ray Baum's Act. Lowvoltage cabling, professional services, architect/engineer review and a contingency allowance are included.
